Review how maintenance grading is being performed

BACKGROUND

Cr Foulkes-Taylor has previously requested the development of a maintenance grading instruction for our grader operators.

The CEO and Cr Foulkes-Taylor along with grader operator Glenn Pinnegar worked through the suggested format of maintenance grading south of Ballinyoo Bridge in August.

Councillor Foulkes-Taylor has drafted a "best practice" guide for maintenance grading.

Guidelines for Maintenance Grading in the Murchison Shire.

Maintenance grading

- 1. The first passes with the grader are to begin on one edge of the normal running surface (typically about three to four metres in from the windrow) and while cutting in deep enough to take off any small bumps and the tops of the corrugations, yet not so deep as to tear up the road surface, work across the road finishing the same distance out from the other side. This so called "corrugation cut" is crucial to re establishing a smooth running surface, and would usually take between two and three cuts.
- 2. The next step is to begin grading from the opposite edge of the road that you began your first cuts, working your way back over the road "losing" most of the dirt that has been picked up from this side as well as the corrugation cut windrow on the running surface. The aim should be to have a very minor or nonexistent windrow on the finishing side of the road.
- 3. If the batters are part of the maintenance programme, they need to be graded with a relatively sharp angle on the blade and with just enough weight on to remove the regrowth while disturbing the minimum amount of soil possible.
- 4. Where practical spoon drains should be graded from out wide, back towards the road, so as to give the water travelling down the side a decent blocking bank to help it veer off down the drain.
- 5. When approaching grids, it is important to have enough dirt on your blade to be able to deposit a reasonable amount in the last few metres before the concrete. If you are left with an excess at the edge of the grid a good way to lose this is to back blade over the preceding 3 to 4 metres. All care should be taken not to fracture the concrete, hit any steel rails or flatten the grid wings.
- 6. If a ripper mounted rear roller is fitted to the grader then this should be engaged at all times while on the running surface of the road

The new regulation 34 requires that local government report on a monthly basis and prescribes what is required to be reported with the intention of establishing a minimum standard across the industry.

Section 6.4–Specifies that a local government is to prepare such other financial reports as is prescribed.

Local Government (Financial Management) Regulations 1996

Regulation 34 states:

- (1) A local government is to prepare each month a statement of financial activity reporting on the sources and applications of funds, as set out in the annual budget under regulation 22(1) (d) for that month in the following detail:
- (a) Annual budget estimates, taking into account any expenditure incurred for an additional purpose under section 6.8(1) (b) or (c);
- (b) Budget estimates to the end of month to which the statement relates;
- (c) Actual amounts of expenditure, revenue and income to the end of the month to which the statement relates:
- (d) Material variances between the comparable amounts referred to in paragraphs (b) and (c);
- (e) The net current assets at the end of the month to which the statement relates.

Sub regulations 2, 3, 4, 5 and 6 prescribe further details of information to be included in the monthly statement of financial activity.
