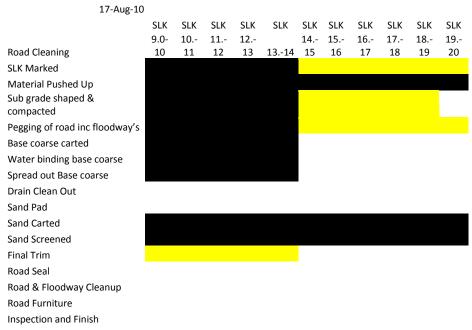

MATTER FOR CONSIDERATION

Reduction of Elected Members for the 2011 Ordinary Election

BACKGROUND

As part of the State Governments structural reform process, reduction of elected members to between 6 and 9 has on the Department of Local Governments agenda.

During the first phase of structural reform the Shire of Murchison was required to complete a checklist of the local government. The Shire of Murchison had listed to reduce the number of elected members from 7 to 6.

The shire of Murchison runs a two ward system, the Darlot Ward and the Ballinyoo Ward. The elected member make of this is

As required by the Local Government Act 1995 the shire is required to conduct a review of wards and representation every eight years. The last review was conducted in 2008.

Minister Castrilli has sent a letter to Council for their consideration of making this reduction for the 2011 elections in October 2011.

There are three options for council to consider here;

Option One: Do nothing

Option Two: Complete a review of wards and representation and submit the Local Government Advisory Board.

Option 3: Reduce elected members to six, and utilise the reduction being one of the seats in the Darlot ward that expires on October 2011. This is achieved by council considering the change to be minor in nature.

STATUTORY ENVIRONMENT

The following framework applies for changes to representation under the Local Government Act 1995 – Members of council

Section 2.17(2) - If the method of filling the office of mayor or president is election by the council, the council is to consist of not less than 6 or more than 15 councillors.

Changing the number of councillors

Section 2.18(3) - The Governor, on the recommendation of the Minister may make an order to change the number of councillors as changing the councillors for a ward or a combination of these.

Section 2.18(4) - The Minister can only make a recommendation if the Local Government Advisory Board (LGAB) has made a recommendation under Schedule 2.2.

(Clause 8(b) of Schedule 2.2 applies in this instance).

Local government may propose ward changes or make minor proposals

Schedule 2.2(5) - A local government, whether or not it has received a submission may -

- a) Carry out a review of whether or not an order under section 2.2, 2.3(3) or 2.18(3) should; in the council's opinion be made;
- b) Propose * to the LGAB, the making of an order under Section 2.2(1), 2.3(3) or 2.18(3) if in the opinion of council the proposal is
 - I) One of a minor nature; and
 - ii) Not one about which public submissions need be invited;

Or

iii) Propose * to the Minister the making of an order changing the nature of the district or a ward.

*Absolute majority required

Reviews

Schedule 2.2(7) – Before carrying out a review, a local government has to give local public notice advising –

- a) That the review is to be carried out; and
- b) That submissions can be made on not less than 6 weeks after notice is given (date to be fixed). The local government is to consider the submissions made.

Recommendation by Advisory Board

Schedule 2.2(10)(1) - Where under clause 5(b) a local government proposes to the LGAB the making of an order under section 2.2(1), 2.3(3) or 2.18(3), and the LGAB is of the opinion that the proposal is –

- (a) One of a minor nature; and
- (b) Not one about which public submissions need be invited, the LGAB in a written report to the Minister, is to recommend the making of the order but otherwise is to inform the local government accordingly and the local government is to carry out a review.

Extra Ordinary Election for Darlot Ward

BACKGROUND

Cr Walsh has given written notice of his resignation

Council would also be aware of the Minister's intention as part of the structural reform program announced, regarding Councillor Representation. In addition to the push for amalgamations, the Minister's stated intention is that there should be only 6 to 9 elected members.

This matter requires immediate decision, as there are several options open to Council, each of which has its own timeframes and deadlines –

- 1. retain seven elected members In which case a decision needs to be made as to either -
 - an extraordinary election, within 4 months of effective date of resignation, that is, by 21
 September 2010, or
- 2. reduce to six elected member

Extraordinary election

Under the Local Government Act s.4.9 (1) a date for an extraordinary election is to be set by either the President or Council within one month of notice of resignation being received, unless –

- application is made for the vacancy to remain unfilled until the next local government elections date, subject to conditions and requirements
- the number of elected members is reduced

Vacancy to remain unfilled

s.4.17 (3) stipulates that the vacancy can remain unfilled, only if 80% of positions are occupied. As 80% of 7 councillors are 5.6, it is possible that 80% would be considered to be 6 elected members.

Should Council decide not to seek to reduce the number of elected members from seven to six, there will need to be an extraordinary election held, either as per the LG Act timetable (within 4 months of the vacancy occurring, i.e. by 21 September 2010),

I had requested some more information from the ACEO;

Greetings Ron

At present the Dartmoor – Lake Nerrammyne Road is a road of Regional Significance as is the Mullewa Carnaryon road.

With the increased traffic volumes that would follow, funding through the RRG/Grants Commission would be increased giving both Shires the ability of continuing the 4M seal north of Yuna and eventually meeting the Mullewa Carnarvon Road 4KM to the North of Bullardoo Station Homestead.

This would coincide with the Murchison Shires plan to continue their sealing program to the South from the Murchison settlement to Mullewa.

This road would provide inter regional road access between the Midwest/Murchison and the Murchison/Gascoyne regions, as well as easier access to the SKA project, Geraldton and Northampton.

This would also be a popular road link with tourists as it would provide a shorter route for traffic from the Northern Midwest to towns in the Murchison Region.

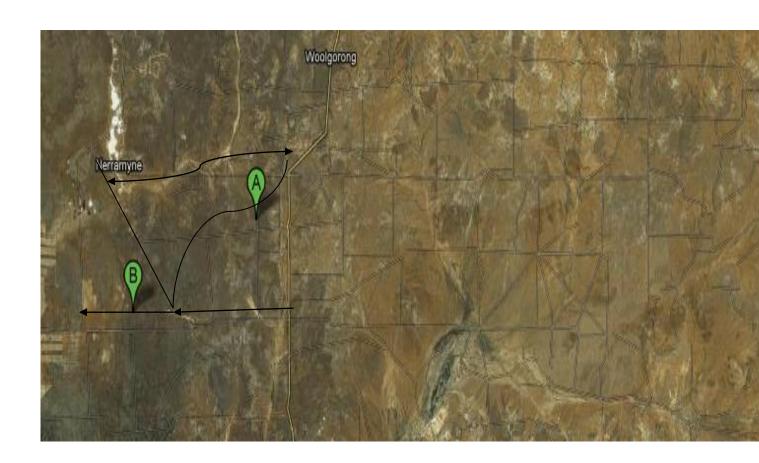

The Rabbit Proof fence goes for 19.8km until it comes to an intersection where a new fence runs in a North West direction. The old fence is still visible and runs through to the Lake Nerrammyne Road. From this point the road continues past Mallee Station until it hits the Dartmoor road.

If a road is built from the lake through to Carnarvon Mullewa Road, then it would in water course.

A road could be built across from the old rabbit fence to Pinegrove; this option would most certainly attract heritage surveys etc.

I met with ACEO Murray Brown and Works Supervisor Robbie Foulkes-Taylor at the Chapman Valley Office, to discuss this road.

The Chapman Valley Shire would like to progress the road as a collaborative arrangement.

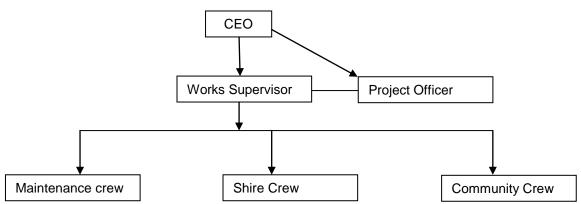
BACKGROUND
