

Pastoral specialist joins team

THE Rural Financial Counselling Service of WA (RFCSWA) has welcomed on board a pastoral specialist as part of its rural financial counselling team.

WA's pastoral industry is a unique sector and it has faced challenging conditions in recent seasons. For that reason, this new Rural Financial Counsellor will focus solely on the pastoral industry — but he's actually not that new.

John Dymond had only recently retired from the RFCSWA but jumped at the chance to return when he was offered the opportunity to work with pastoralists and their communities.


He rejoined the RFCSWA team in June and has spent the past couple of months on the road, meeting people across the southern rangelands.

John's keen interest in the industry can be traced back to his first stint of on-farm work experience in the 1970s at a station just outside of Sandstone.

"I came from a grazing property in New Zealand, so it was a big eye opener — just to see the scale and understand how a grazing property like that operated," he said.

John spent more than 30 years teaching farm management at Muresk, including the arid land management course.

"It was a great unit, but it was also a really good excuse to take students on

Poor seasons and rising debt are situations that many Rural Financial Counselling Service of WA clients are familiar with and have worked with a Rural Financial Counsellor to successfully navigate.

South East farmers Jim and Jenny were hit by five years of drought, followed by two below-average seasons.

The poor seasons saw their business chew through its cash reserves, resulting in pressure from the bank to reduce debt. Their Rural Financial Counsellor was able the need for ongoing finance to run the business until a more permanent debt resolution could be organised.

"Just knowing that you can pick up the phone and there is somebody there that you feel comfortable with and you can talk to, that's one of the biggest helps," the couple said. "We can see our way clear now, to doing what we want to do with our future."



Have Your Say on the Future Drought Fund

5 November 2019

- Independent Committee's planned public consultations begin this week
- Meetings across Australia
- Opportunity to participate in person or online

The Future Drought Fund Consultative Committee's public consultations across Australia have begun.

The committee has provided the government with their plan for drought resilience through the fund but must now consult the community as part of the process legislated by the government. The allocation of funds for projects and activities will be guided by the resulting Drought Resilience Funding Plan.

Federal Member for Durack Melissa Price is urging all farmers and pastoralists to have their say.

"This is an important opportunity for future planning for the Federal government to support Agriculture across Durack," Ms Price said.

"There is an option to book a meeting with the committee in Merredin next Tuesday November 12. However I appreciate that many people in Durack are now busy with the annual grain harvest or summer stock care so you can have your input online," she said.

The Consultative Committee is particularly interested in hearing from farmers, local communities and industry organisations.

Minister for Drought David Littleproud said the consultations will help inform the Committee on the best ways for the Future Drought Fund to invest in drought resilience.

"The Fund will provide \$100 million each year from 1 July 2020 for projects that enhance our preparations and responses to drought," Minister Littleproud said.

Carnarvon CRBA Seeks Committee Members From Murchison

The Carnarvon Rangelands Biosecurity Association (CRBA) is a not for profit that assists pastoralists around the Gascoyne, including those within the Murchison Shire, with feral animal and declared plant control. The primary purpose of the CRBA is to "aid" in the control of these declared pests utilising funding from the Declared Pest Rates paid by landholders on pastoral stations. These funds are matched dollar for dollar by the WA State Government. The area the CRBA covers is well beyond the scope of funds it has access to, and therefore it is important to have input into key hotspot areas/properties that need addressing. Please let me emphasise the financial constraints and limitations on manpower to be able to provide an extended number of days to each property. The committee is diligent in ensuring areas are serviced.

The CRBA Committee is made up of volunteers, with numerous other volunteer roles required to run the group. We aim to have a mix of committee members and volunteers from within each shire region. Currently Sandy McTaggart, who has sat on the committee since 2014, is the only representative from the Murchison. Andrew Whitmarsh and Greydon Mead each hold two volunteer roles, being bait rack and LPMT co-ordinators.

With this in mind the CRBA asks pastoralists within the Murchison Shire to put their hand up to become members of the committee. This is important to ensure we are servicing the area as ratepayers expect, within budgetary constraints. Meetings occur face to face approximately twice per year, with phone meetings as required. The time commitment is minimal, however your input is very much needed and appreciated.

The CRBA Executive will be requiring a change; 1) due to term expiry, 2) fresh ideas to keep the dream alive and 3) Constitutional change requirements.

Panforte di Siena

(Recipe from Australian Women's Weekly Italian Cooking circa 1988)

Panforte, or Siena Cake, is one of my favourite Christmas treats and it makes a wonderful gift. I came across this recipe at a family wedding recently and thought it was delicious. As it turns out, I already had the recipe in my old Women's Weekly Italian Cookbook! This version of panforte is a bit simpler (and cheaper) to make than some but I think the balance of spice, fruit and nuts is really good. I particularly like the inclusion of dried apricots. I think I will add some glace ginger when I make it because I LOVE ginger!

Ingredients

125g blanched whole almonds 2 tablespoons cocoa

125g roasted hazelnuts 1 teaspoon cinnamon

60g glace pineapple 60g dark chocolate

60g glace apricots 1/3 cup sugar

60g mixed peel ½ cup honey

2/3 cup plain flour

Method

Grease and line the base and sides of a 20cm (8 in) round cake tin with baking paper (sandwich sponge tin is perfect and not too deep). Or you can divide mixture and make 2 or 3 smaller cakes.

Spread almonds on a tray and roast in a moderate oven until lightly golden (approx. 5-7 mins). Once cool to handle, chop the almonds and hazelnuts roughly and combine in a large bowl with the chopped glace fruits, mixed peel, sifted flour and cocoa, and cinnamon. Mix well to coat the fruit and nuts.

Melt chocolate gently in the microwave or over a double boiler. Place sugar and honey in a separate saucepan and heat and stir over a low heat until sugar has dissolved. Bring to the boil and reduce to a simmer, uncovered, for 5 mins. Be careful as this mixture can boil over and be very hot.

Combine melted chocolate and sugar mix with flour and fruit. Mix well and quickly as the mixture will start to set. Spread mixture quickly and evenly into the prepared tin.

Bake in a moderately slow oven for approx. 35 mins. Remove from oven and cool in tin.

Once cake is completely cool, take out from the tin and wrap in cling film and aluminium foil. For gifting you can wrap it in brown paper and tie with string for an authentic look. Dust with icing sugar before serving if desired. It will keep unrefrigerated for several weeks.
