13.2 Works Report – Works Supervisor

Construction Crew

The construction crew are progressing well with the re-sheet job north of McNabb Rd intersection. Due to the last rain event they had to deal with a bog hole to the north of their job. Hopefully this will have dried out enough for them to tackle around the week starting 22nd July and this road can once again be opened without any restrictions. The construction crew were also on duty over the polocrosse weekend, cleaning bins, dragging and watering and attending to various small jobs around the settlement. My thanks to them for attending to the necessary jobs over the weekend.

Maintenance Crew

The maintenance crew have graded from the south boundary to the start of the bitumen twice due to the last rain event. Feedback from various people over the polocrosse weekend was positive about the condition of this section of road. They then moved to the Beringarra-Pindar Rd. I have arranged with Trevor, the depot manager at Mullewa for the City of Greater Geraldton that we will grad down to Pindar when our graders are working down there and they will grade to the wreath flowers when their graders are grading east of Mullewa. Time will tell how successful this arrangement will be.

Bilung Creek Crossing

I am aware that there has been some discussion regarding this crossing in the past. However, I feel it is time Council give this crossing some urgent thought. The concrete is starting to crack and break at an ever increasing rate. I also want to make Council aware that this crossing has 3 different widths ranging from about 4m to nearly 6m. On my last inspection on Monday 15 July I noted a section that could be dislodged by a road train or some other heavy vehicle in the near future.

Road Closures

I would welcome feedback from Council and the community on how we can simplify and make our Road Condition Reports (RCRs) more user friendly for both our staff and road users in general I also feel some thought needs to go into how we can go about enforcing road closures. We have had several instances in the past month where road closures have been ignored resulting in the Shire sitting with some fairly serious repair bills and inconvenience to road users.

Beringarra-Cue Road

By the time Council meets the concrete cut off walls on the Beringarra-Cue Rd should have been completed. The construction crew will then move over and start bunding work to prevent further and ongoing erosion of the road pavement.

Flood Damage

Pickups for Flood6 have been completed and are now in the process of being assessed. Flood5 handovers will probably take place in the week of 22nd or 29th of July.

Council Comments

Matter for Consideration:

Council to consider the urgent repair to the Carnarvon - Mullewa Road.

Background:

Following recent heavy rainfall the Carnarvon – Mullewa Road (referred to in future as The Road) was closed by the Shire of Murchison north of the Settlement at the Beringarra- Byro Road and it was closed at the Murchison / Upper Gascoyne boundary by the Shire of Upper Gascoyne. The Road is still closed north of the Settlement and the Shire of Upper Gascoyne has maintained the closure at their end. However, travellers are continuing to travel the closed portion of The Road ignoring to the dangers and potential to cause damage.

Unfortunately damage has occurred and the road is in need of repair. The Works Supervisor visited the site again on Tuesday 16 July 2019 and established that because of water still being present no machinery could be effectively utilised until the week commencing 22 July 2019.

Comment:

The Works Supervisor has placed road closed signs at the top end of The Road within the shire boundary thus causing an annoyance factor for users but absolutely necessary in terms of minimising damage and to avoid any future liability claim should an accident occur.

The Works Supervisor estimates there to be approximately \$50,000 in cost to repair the road and make it trafficable. As this is a main access to the north and return to the south the Acting CEO, on the authority of the President under the Local Government Act 1995 section 6.8(1)(c), authorised the Works Manager to undertake the necessary repairs to make the road trafficable. The Local Government Act 1995 allows emergency works to be carried out, even if not in the Budget, on the approval of the President. It reads as follows:

"6.8 Expenditure from municipal fund not included in annual budget

(1) A local government is not to incur expenditure from its municipal fund for an additional purpose except where the expenditure –

- (a) is incurred in a financial year before the adoption of the budget by the local government; or
- (b) is authorised in advance by resolution*; or
- (c) is authorised in advance by the mayor or president in an emergency."

The Shire President considered this an emergency and authorised the repair to The Road prior to the adoption of the budget and also prior to the Council meeting of the 25th July 2019.

Council received a letter from CRBA requesting a donation to assist with the ongoing costs of maintaining biosecurity management within the Shire of Murchison.

Comment:
