

2021-2022 RESTRICTED BURNING

A **Restricted** burning period is operational in the Murchison Shire from

28 September 2021 to 30 April 2022

Hazard Reduction Work - Bush Fires Act 1954

As a measure to assist in the control of bushfires or prevent the spread of a bush fire, all owners or occupiers of land within the Shire of Murchison are required to install and maintain firebreaks.

Pastoral/Rural Areas

Three metre wide trafficable firebreaks are required to be installed on the land and to be clear of all flammable material. All buildings require a minimum twenty metre clearance of all flammable material and graded/ploughed/hoed or chemical applied firebreaks should be installed at the outer edge of that clearance.

Fuel Dumps (Fuel Storage)

On all land where fuel drum ramps are located and where fuel dumps, whether containing fuel or not are stored, clear and maintain an additional firebreak at least four metres wide around any drum, ramp or stack of drums.

Advice Is Available

Advice on how to protect your home and family from fire, and when and how to burn off, is available from

the Chief Bush Fire Control Officer (CEO) or Community Emergency Services Manager (CESM).

Barbecues Incinerators & Campfires

Gas and electrical barbecues are permitted to be used at any time.

Campfires, solid fuel barbecues, incinerators are prohibited on days of VERY HIGH and EXTREME Fire Danger

Burning Off

Burning is prohibited on days of VERY HIGH or EXTREME Fire Danger. Permits are required during the **RESTRICTED** burning period. A permit can be gained from the Shire Office. A permit is invalid on days of VERY HIGH or above.

BUSH FIRE CONTROL CONTACT DETAILS
