As the Works Staff are to commence work on 29<sup>th</sup> January and the Council meeting is not until 15<sup>th</sup> February the CEO recommended that Council consider completing the realignment of the Twin Peaks Wooleen Road through the rock section approximately 7kms north of the Twin Peaks Homestead as this job had been raised on several of occasions yet remained outstanding. Should this job be completed before 15<sup>th</sup> February Butchers track was in need of some remedial work following recent heavy rains.
