My report for Local Government Convention, Roads Forum and State Council

Firstly I would like to thank Council for allowing Natalie and I to attend the Local Government Convention. I must say It was extremely well organised – well attended – accommodation and venue was excellent.

The roads forum was held on Wednesday the 5th of August and approx. 300 delegates attended. We were welcomed by the WALGA President – councillor Bill Mitchell, He then introduced the minister for transport – Simon O'Brien. The minister spoke about the restructuring of the department of transport and its key programmes, they included Oakajee which is the biggest project on the Governments Books at the moment, and He mentioned that because there was no Rio to underpin operations in the Mid West – it was vital that the aggregate of all projects is sufficient to make it happen. On matters of grain on rail, Government has brought all players together into a freight logistic council, they meet frequently and it appears to be working well. The State road funds to local Government agreement are up 6 Million dollars to 122.9 million dollars over the next financial year. He spoke about the regional Airport development scheme and for the 09/10 financial year is 6.73 million dollars and that scheme has now provided 21 million dollars since 1997. He believes that they being the nation and liberal Government are up to the challenges and he mentioned that the focus remains on stimulating private sector investment – creating jobs - having the capacity to meet future demand for industry and local business.

Ken Travis - the shadow minister for Transport spoke also and my analysis of Ken is that he likes Harry Potter. He mentioned Harry on numerous occasions without saying much else.

The WALGA President – Bill Mitchell addressed the meeting again and mentioned that 474 Million Dollars is needed just to keep the current road network intact. He mentioned that the road agreement is a growth tax and that it was worth 450 million dollars 5 years ago to this year being worth 550 million dollars, Local Government is working closely with the State Government to make roads safer.

The acting Director General of Transport Menno Henneveld spoke about some of the things they will need to do:

- Vision Objectives strategies for transport
- Examine interface and areas needing attention
- Lift the profile
- Integrated approach to transport planning and transport services provision
- Stronger relationships with partners including State
- Playing a key role in planning

KEY AREAS OF BUSSINESS

- Strategic transport policy
- Strategic transport planning
- Operations transport Services
- Licensing services

KEY AREAS OF FOCUS

- Leadership
- People capacity capability and culture
- Relationships
- Transport planning
- Provision of Services

Menno mentioned that they employ about a 1 thousand people

This is the first time That I have attended the Road's Forum and I believe that other councils might get more out of it than Murchison.

The Local Government Convention was based on Innovation – Regeneration and Renewal. There were far too many speakers for me to comment on every one of them but I will mention the ones that I thought had the most impact on me. A Gentleman by the name of Frans Johansson from America – Frans was raised in Sweden by his African American Indian mother and his Swedish father He wrote a book which was voted one of the best business books in 2004. His address was totally inspiring and he spoke mostly about the glass being half full rather than the glass being half empty, about planning for mistakes and failures and looking at life through eyes other than your own. He also spoke about having a go at doing things even if you fail – try again and again and spoke of many different instances where people had been knocked back time and time again for building things or inventing things and through sheer determination they had succeeded.

Other terrific speakers were Jason McCartney who spoke about the Bali bombing and the horrific aftermath of Bali – He spoke about the courage shown by the Balinese people in rescuing the victims – the long battle he had with his life threatening injuries and how motivated he was to play AFL football again and how he had to break through the pain barrier time and time again in his quest to achieve that one thing to play AFL football again.

The Young Australian of the year Khoa Do gave the Key note address at the conference and he is now a film director, a screen writer and a teacher. As a young boy – when they left Vietnam as refugees they were plundered by pirates on 2 occasions - On the Second occasion they had nothing to offer and the pirates threatened to throw the youngest child over board if they didn't tell them where their valuables were hidden – they of course had no valuables – for some reason the child was spared – that child was Khoa Do. Shortly after arriving in Australia Chua's father left the family and it was up to his mother to raise the 3 children. They literally had nothing – the 2 boys lived in hand me down girls clothing for the first 2 years. It was an or inspiring story of a refugee coming to our country with only the clothes on his back and rising to greatness that we can only dream of.

The AGM was attended by approx 220 delegates.

On matters of State Council – a motion was passed requesting that Local Government seek an extension of time to 30th of September for the sector to formulate its final submissions - I understand this has been granted by the minister – the CEO Ricky Burges spoke about having a plan B in regard to the government's reform process and that all staff at WALGA know that they have a task to do and that they need a strategic plan –that plan will be out by Feb 2010. The plan will be known as Better Local Government. This is because some people are saying that the SSS is regarded by some as being yesterday's news. She also mentioned that the new TV commercials will be rolled out on the 24th of August and are to enforce that Local Government is not yesterday's man .

The Journey of Renewal

Opening address- Frans Johansson

City revitalisation-building future places for people.

Dote Keelung (General Manager Major Cities Unit, Infrastructure Australia)

- 339 million for Oakajee port & rail project
- WA has the biggest population growth in Australia-3.1%, Australian average is 1.9%
- WA needs to prepare for a population growth of 120% by 2056

- Renewal of aging infrastructure is required
- The cost of living out of cities is preventing people living in non urban areas
- Better public transport required along with partnerships with businesses

Brendon Grylls MLA (Minister for Regional development)

- For WA to keep its AAA rating 25 million was cut from the budget
- Would like to increase the boarding/home away allowance
- RFDS have received the funding for three new planes and for extra staff
- There will be no cost shifting of R4R money into other departments
- 200 gigalitres of water being held under pressure in the Pilbara mining areas can be shifted to Perth. This is much more efficient that the desalination plant (30 gigalitres)
- ASCAP,SKA and MWA are being held up by the government will not free up land
- Is not pro forced amalgamations

John Castrilli MLA (Minister for Local Government; Heritage; Citizenship and Multicultural Interests)

- Legislation allows for the formation of ROC instead of amalgamations
- Prefers amalgamations-these would take up to two years to set up.

Tony Brun (CEO, City Geraldton/Greenough)

- Had to increase shire rates by 33% over five years so as to cover the replacement of old assets and the development of new assets
- Wished to form a super regional shire responsible for all road, sewage, water port and rail

Towards the New Reality

Allan Jones (energy and Climate and Director/Trustee, Sustainable Environment foundation, UK

- 2/3 of heat units go into the earth's atmosphere-adds 24 billion gigalitres of water an hour to the atmosphere=a billion dollars of lost electricity
- By changing for coal powered generators to a hydro/gas motor they the water previously lost t the atmosphere is saved and used to run the motors, therefore paying for the engine in three years.
- New sky scrapers are being built with solar roofs and windows=20% green energy production
- By turning landfill into renewable energy you save 2 million tonnes of green house emissions

Peter Andrews (Natural Sequence Farming)

- All water storage should have vegetation growing on it. This can save up to eight feet of evaporation per day
- Slow the flow of water by any means
- Every plants that grows converts into a product that manages water and only a living plant allows you to use it profitably
- Dew is the purist and most available water on a property
- Non edible plants, whilst growing, extract moisture from deep soils
- Plants enrich the landscape and edible plants extract nutrients from surface soil

General Comments

- Congratulations to Bill and the team
- I enjoyed the fact that everyone was listening to the same speaker (no split sessions)
- It was very informative
- The food it may be worth trying to get the caterers to use some regional produce e.g. Murchison goat, beef or mutton

WALGA Convention and Trade Exhibition

Firstly, thank you to the Murchison Shire for enabling Lian and myself to attend the WALGA Convention this year. Lian and I both look forward to attending this convention as representatives of the Shire of Murchison as we feel it is a great opportunity to catch up with colleagues, both old and new. To then be able to discuss the information received and see the exciting new innovations that are presented, with a group of not only our shire representatives, but with representatives across the state is a rare and important occasion that should not be missed.

The special theme this year – Regeneration, Innovation, Renewal, Revitalization and Renaissance – whilst perhaps hiding the true agenda of the approaching deadline for reform submissions or the hidden tiger of forced merger, also provided on a national level, updates on the move to constitutional recognition for the local government sector. The Hon Colin Barnett made a rather forceful speech to encourage Shires to merge, on the basis that historically, some local governments have operated unethically and/or made decisions that not necessarily benefited their shire or the community that they represent; a problem as a small shire with no town, we are yet to encounter! As an adjunct to Colin Barnett's speech, perhaps Local government may indeed encourage dishonest men, but given the evident dishonesty in both State and Federal Government, it could be seen as a necessary skill to advance up the ladder!

The speakers are always very entertaining and uplifting, with no exception, but the breakfast talk with Jason McCartney, who, as a victim of the Bali bombing, shared with us his long road to recovery, culminating in his return to AFL football, was truly an uplifting story of both courage and true grit with the resounding message that with determination, we can all achieve.

Khoa Do, the 2005 Young Australian of the Year, was very amusing with his amazing journey of courage, resilience and hope amidst incredible opposition. He left Vietnam aged 2 in a small boat with 40 others – to become one of Australia's brightest stars as a feature film maker.

Dr Chris Coton, of BT Funds Management, gave a fascinating talk on the Recovery – an Economic Outlook. It was a financial health update for Australia outlining where we are currently at and what lies ahead in the future. Australia is performing very well on a world scale, our banks especially, with Westpac now number 8 in the world ranking, thanks to the Bradbury approach – for those of you who are not familiar with this approach Mathew Bradbury won a gold medal in the winter Olympics because all the other contestants fell over!! Dr Coton went on to say that Japan is our number 1 trading partner and the outlook for Australia is very good with the US recession and economy on the up, thanks to President Barrack Obama, and our stock market is also on the up this year too. Dr Coton gave an amusing quote by Wayne Swan (Labor Treasurer) to explain the last 8 months – "liberal left Australia teetering on the edge of a cliff – at least under labor it has taken a step forward!"

I feel that through all of these experiences and by talking to my fellow councilors, make my position as a Shire Councilor more rewarding and help me to understand the big picture that all of us in the Murchison Shire face.

BALLINYOO BRIDGE - CONSERVATION ORDER (STOP WORK ORDER)

Main Roads of Western Australia Bridge Number 837, Portion of the Murchison River Bed being unallocated Crown Land and portion of Road Number 8389 being the Carnarvon Mullewa Road as depicted on Heritage Council of Western Australia Diagram numbered 16581 together with the embankments and structures thereon.

I am writing further to conversations you have had with officers of the Office of the Heritage Council of Western Australia when you advised of the Shire's intention to demolish *Ballinyoo Bridge* before the place can be considered for possible inclusion in the State Register of Heritage Places.

On 17 August 2009, the Minister for Heritage issued a Stop Work Conservation Order, pursuant to section 59(2)(b) of the *Heritage of Western Australia Act 1990* (the Act), in respect of the above place. A copy of the Order is enclosed for your information.

The Order prohibits the demolition, damage or alteration of the parcel of land comprising Main Roads of Western Australia Bridge Number 837, Portion of the Murchison River Bed being unallocated Crown Land and portion of Road Number 8389 being the Carnarvon Mullewa Road as depicted on Heritage Council of Western Australia Diagram numbered 16581 together with the embankments and structures thereon. The Order also prohibits the carrying out of any activity that may detrimentally affect the cultural heritage characteristics of the place.

The Order is effective from 17 August 2009 and pursuant to Section 59(7)(d) the Act the Order will remain in force for 42 days. Please note that section 61(1) of the Act provides for a penalty of \$10,000 and 2 years' imprisonment for a breach of a Conservation Order. In addition, a daily penalty of \$1 000 may be imposed.

Australia Act 1990 and the Stop Work Order signed by the Minister are attached for your

BACKGROUND

The status of the RRG submissions for the Shire of Murchison is;

• Carnarvon Mullewa Road 1 Ongoing submission for reformation and resheeting works

Greenfield has prepared 1 RRG funding submissions on behalf of the Shire of Murchison as requested;

1. Carnarvon Mullewa Road

This submission is for the continuation of an ongoing program to reform and resheet the road pavement ahead of the shire applying a 4m bitumen seal. The programmed works for the 2010/2011 submission commences at SLK 192.0 and finishes at SLK 197.0.

We have compiled an estimate based on industry production rates/costs.

We estimate the 5 kilometre section of seal widening should cost in the order of \$166,838 + / - 20% (\$33,368 per km).

This cost estimate assumes there is minimal clearing, moderate formation works, the gravel is carted using 3 semi tippers and is within 13km of the jobsite, no culvert works and the cost of the seal preparation/application etc being a separate project which will be at the shire's cost. There is an allowance within the estimate for survey and engineering support.

If the submission is successful, the financial break up of this cost would be (Shire = \$55,613 + RRG = \$113,226).

This submission has a score of 77.69 which is very low (the cut off score for successful applications in 2008-2009 was 93.4).

This being the case it is pretty certain the Shire of Murchison will only receive the minimum allocation (\$50,000).

With this in mind it is unlikely that this submission will be successful and the only way that I see to increase the project score is to obtain higher traffic data therefore it is advisable to have the traffic counters on this road during the peak traffic activity periods (tourism times) over the next 12 months.
